- Thursday, June 26th: Depart STL at 1:25pm to arrive at JFK at 5:00pm. Depart JFK at 10:00pm to arrive at Shannon at 9:45am on Friday, June 27th to pick up four 8/9 person vans.
- Friday: Drive to Dingle, Ireland
- Saturday: morning practice session & afternoon pub crawl
- Sunday: Rugby Match #1 (Dingle Rugby Club)
- Monday & Tuesday: free to explore Dingle peninsula, Ring of Kerry
- Wednesday: Rugby Match #2 in the evening (Tralee Rugby Club)
- Thursday & Friday: open for tours
- Saturday: Drive to accommodations in Shannon
- Sunday July 6th - 11:25 am departure from Shannon to arrive at JFK at 1:25 pm. Depart JFK at 6:55pm and arrive STL at 9:09 pm

The area that the team will be touring is southwestern Ireland in County Kerry.

COST, Payment Information & Cancellation:

Rate per person: \$1731 plus Delta airlines current fuel surcharges & taxes of \$329.00. **TOTAL PER PERSON: \$2060.** This includes flight, ground transportation and lodging for 9 nights. Payment is due in full by: **May 02, 2008.** No name changes will be permitted after May 09.

Leah and Andy will compile all payment information to submit together. We also need names as shown on passport (Please make sure all passports are valid for dates of travel) and your payment information by May 1st. Check/MC/Visa or Discover is accepted. If paying by credit card we will need the following:

If we fall below 90% of the group space (27 seats) you will lose the deposit of \$100 per person. Once ticketed May 02, tickets are totally non-refundable. You may do a name change for \$150 (this is charged

by Delta) per ticket changed. They highly recommend trip cancellation insurance to protect your travel investment. It costs approx. \$60 for a comprehensive protection plan. You can also check out rates for insurance thru AAA or other local agents.

Thirty seats are now confirmed. Paper tickets will be issued by Delta Airlines. (No E-tickets allowed on groups, per Delta.) Be sure to stress limited luggage allowed per person as airlines are now charging for extra baggage and heavy baggage. Furthermore, there will be 7-8 people per 8-9 seater minivans with luggage!

LODGING:

We have reserved the cottages: Two 4-bedroom & Three 3-bedroom with Southbound Cottages in Dingle with arrival June 27 and departure July 5th. 8 nights. (5 min stroll into town Centre per representative today). Cottages are 2 yrs old, fully stocked with all bed linens, towels etc. There will be a charge of €64 (€8 per day) per cottage for electric. I am waiting to hear from them when this is payable. (I would guess upon arrival/check-in). The nearby Leisure Centre is available to you for a charge of €160. This represents €60 per cottage. GROUND TRANSPORTATION:

Four 8/9 VW Caravelle minivans (manual) with unlimited mileage, CDW (deductable €1900/ \$3000 approx. per van!), airport location fee, Third Party Ins. Pick up Shannon June 27 and drop off July 06. 2-hour grace period allowed with Hertz.
